# Nonprofit Incorporation and Tax Exempt Status Workshop

This workshop provides valuable information about starting a nonprofit organization. State issues to be covered include articles of incorporation, bylaws, and the first organization meeting. Federal issues include the Internal Revenue Code Section 501(c)(3) and corresponding regulations, application for employer identification number, IRS disclosure rules, unrelated business taxable income, charitable contributions, and restrictions on lobbying. A brief overview of nonprofit alternatives also provided. VLA requires **all applicants** seeking Nonprofit Incorporation and Tax Exempt Status services through VLA to attend this workshop before a volunteer attorney can be assigned to them. VLA Membership:</b> One year organizational membership, including access to VLA Legal Clinics and discounts to VLA workshops and seminars.</li><li><b>2. Nonprofit Incorporation and Tax-Exempt Status Workshop:</b> A three-hour introductory workshop held twice monthly. Attendance is a <b>PREREQUISITE</b> to your Consultation with VLA staff and Case Placement with a <i>pro bono</i> attorney. Upcoming workshop dates are listed to the left.</li><li><b>3. Legal Consultation:</b> A VLA staff member meets with you to confirm completion of prerequisites for placement with a volunteer attorney.</li><li><b>4.
