

Nonprofit Incorporation and Tax Exempt Status Workshop

This workshop provides valuable information about starting a nonprofit organization. State issues to be covered include articles of incorporation, bylaws, and the first organization meeting. Federal issues include the Internal Revenue Code Section 501(c)(3) and corresponding regulations, application for employer identification number, IRS disclosure rules, unrelated business taxable income, charitable contributions, and restrictions on lobbying. The Fiscal Sponsorship model will be addressed as an alternative to form a non-profit. VLA requires **all applicants** seeking Nonprofit Incorporation and Tax Exempt Status services through VLA to attend this workshop before a volunteer attorney can be assigned to them. There is CLE credit available on **certain** class dates. Free e-book included.

Assistance to arts and cultural organizations is an important part of VLA's mission. VLA offers a variety of services to nonprofits of all sizes and stages of operation, from forming dance troupes, theater organizations and visual arts organizations to established arts councils and performing and visual arts service organizations.

VLA offers a comprehensive start-up package for fledgling nonprofits and for incorporated nonprofits seeking federal and state tax-exempt status at the low cost of \$775.

This **\$775 package** includes:

- 1. VLA Membership:** One year organizational membership, including access to VLA Legal Clinics and discounts to VLA workshops and seminars.
- 2. Nonprofit Incorporation and Tax-Exempt Status Workshop:** A three-hour introductory workshop held twice monthly. Attendance is a PREREQUISITE to your Consultation with VLA staff and Case Placement with a pro bono attorney. Upcoming workshop dates are listed to the left.
- 3. Legal Consultation:** A VLA staff member meets with you to confirm completion of prerequisites for placement with a volunteer attorney.
- 4. Case Placement:** VLA will seek a volunteer attorney to handle the incorporation and tax-exempt application process for your organization.

Please note that the \$775 fee does not include filing fees or any other out-of-pocket expenses.
